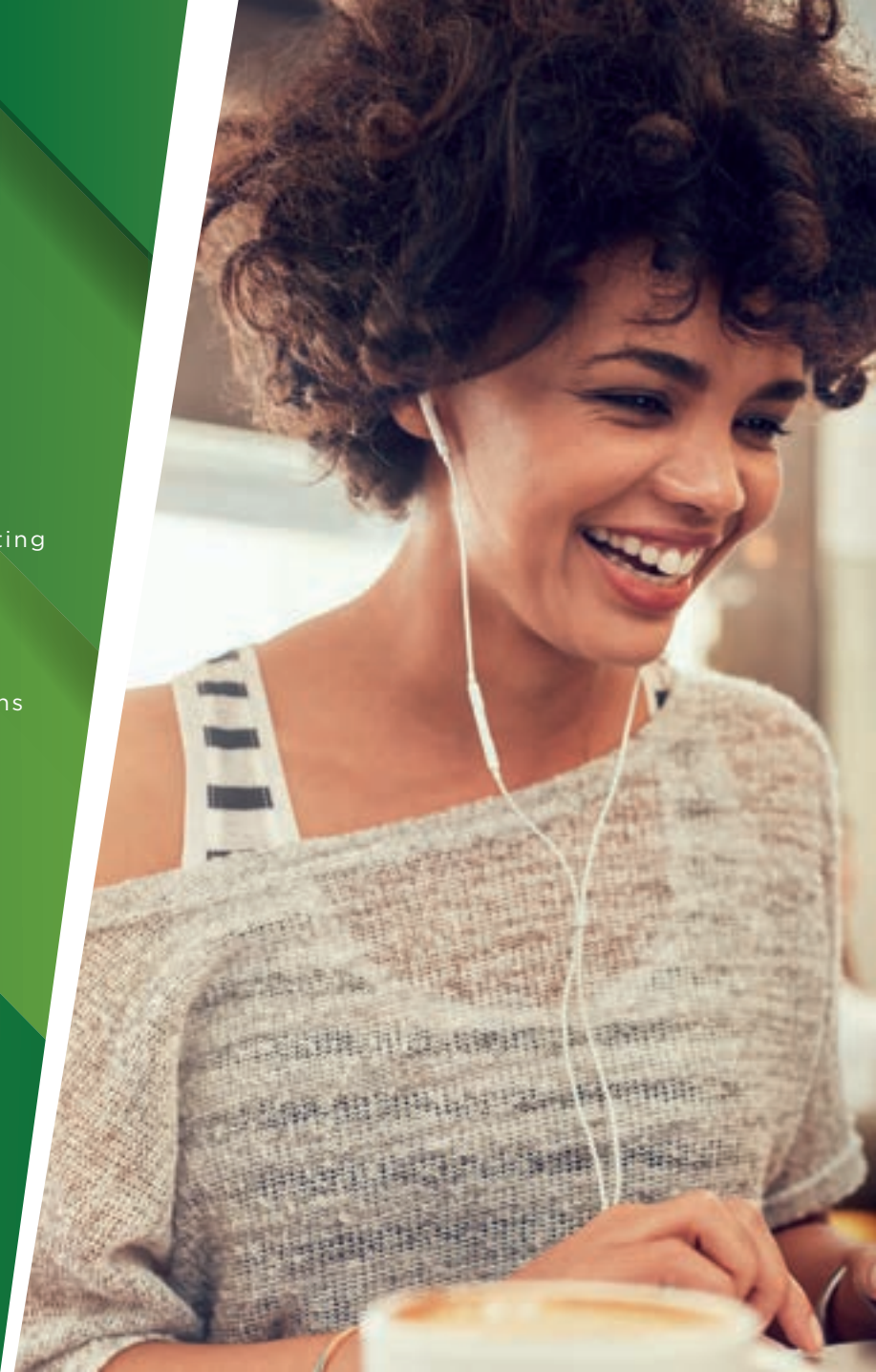

DURATION

- Two-year employment focussed training and education programme
- Remotely invigilated online exams in May/June each year
- Repeat exams in August each year

APPLICATION CRITERIA

- A minimum of 300 CAO points (or equivalent) within the last 5 years with a pass grade in English, and Maths or Accounting
- If you sat the Leaving Certificate more than 5 years ago, you should have a minimum of 300 CAO points (or equivalent) with a D3 in Ordinary level English, and Maths or Accounting
- If you do not have a pass in Leaving Certificate English or equivalent, then you must be able to supply evidence of competency in written and spoken English
- PLC students or other previous qualification holders are eligible to apply if the qualification is in a different discipline and is an NFQ Level 5 or above.
- Applicants should have a flair for accounting and be able to commit to completing the programme syllabus whilst working in full-time employment over the two years

CERTIFICATE FOR ACCOUNTING TECHNICIANS

REGISTRATION CRITERIA

Republic of Ireland applicants should possess one of the following:

- 5 Ordinary level Leaving Certificate grades (including an O6 in English, and Maths or Accounting)
- 2 Higher level and 2 Ordinary Leaving Certificate grades (including an O6 in English, and Maths or Accounting)

Northern Irish applicants should possess:

- Either 1 A-level or 2 AS-levels
- With grades in English, and Maths or Accounting, no lower than Grade C at GCSE level

If you are over 21 years of age but don't possess the minimum educational requirements, you can still register as a mature learner, based on age and experience.

Prior Learning may also provide an entry route for applicants who do not meet any of the above criteria. Those who have successfully completed a nationally recognised qualification such as a QQI award in the Republic of Ireland, or QCA and BTEC National Diploma in Northern Ireland, may be eligible to register.

DIPLOMA FOR ACCOUNTING TECHNICIANS

PUT LEARNING INTO PRACTICE

WHAT ARE THE BENEFITS OF THE WORK PRACTICE PROGRAMME?

- Enables you to apply your learning within a work-place environment
- Safeguards the professional currency of the Diploma and MIATI designation
- Employers recognise the capability and skillset of ATI Diploma graduates
- Enhances progression routes to further studies with professional accounting bodies

WHAT IS REQUIRED?

- Complete two Work Practice modules - the Work Practice Module and the Advanced Work Practice Module - comprising of four work-based tasks each
- The work-based learning takes place under the supervision of a workplace mentor, appointed by your employer, and approved by ATI
- Provide evidence of a minimum of two years' relevant work experience
- This can be gained before, during or after completing your studies

WHEN DO I START?

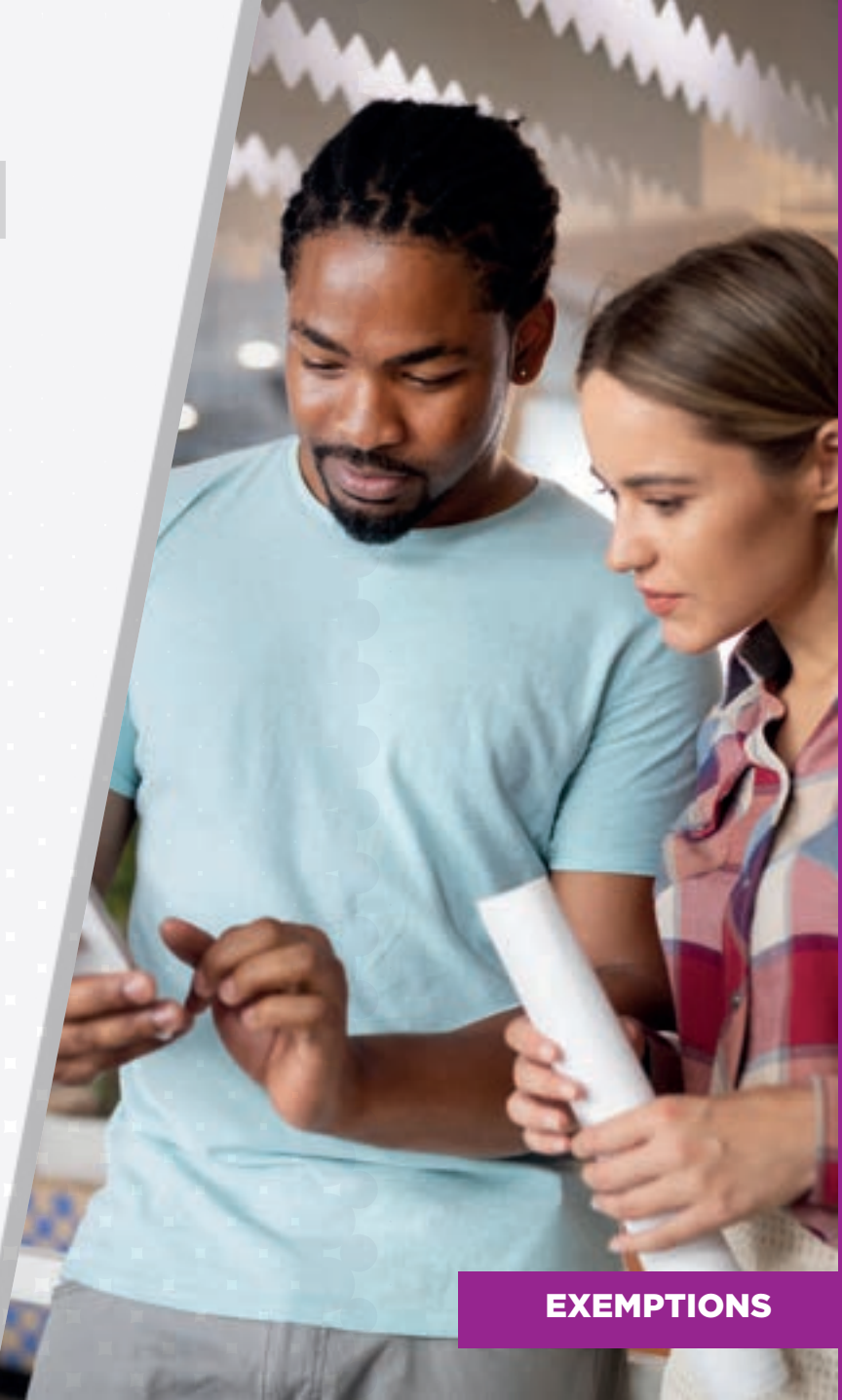
- Once you are actively working in an accounting or finance related role, you can begin engaging with the Work Practice Programme
- The learning outcomes of the Work Practice module are aligned with the Year 1 curriculum
- The learning outcomes of the Advanced Work Practice module are aligned with the Year 2 curriculum
- If you're not currently in a role that enables you to meet the Work Practice Programme requirements, you can complete it following the two-years of study
- Once you have successfully completed the core curriculum modules and Work Practice Programme, you'll be invited to graduate where you'll be conferred with full Membership of ATI*

*The Work Practice Programme replaces the previous Record of Work Experience. If you are a returning student, please refer to the transitional rules on our website

EXEMPTIONS

Prior Learning may be recognised for exemption purposes. If you think you may be eligible for an exemption, then you can apply for one during the registration process.

- If you have completed relevant qualifications within the last six years, you may be eligible for exemptions from select Year 1 exams
- To be considered for exemptions, relevant qualifications must be a minimum of QQI Level 6 in the Republic of Ireland or Level 4 in Northern Ireland (or higher)
- If you wish to apply for an exemption with qualifications achieved in a country outside of Ireland / UK, please use the NARIC (National Academic Recognition information Centre) database in order to obtain confirmation of how your prior qualification maps to the National Framework of Qualifications (NFQ)
- Please note that exemptions are not available for Year 2 exams
- You can apply for exemptions free of charge, though there is a charge of €70 / £65 to accept any exemptions that are offered
- **The closing date to apply for exemptions is Wednesday, 12th October**

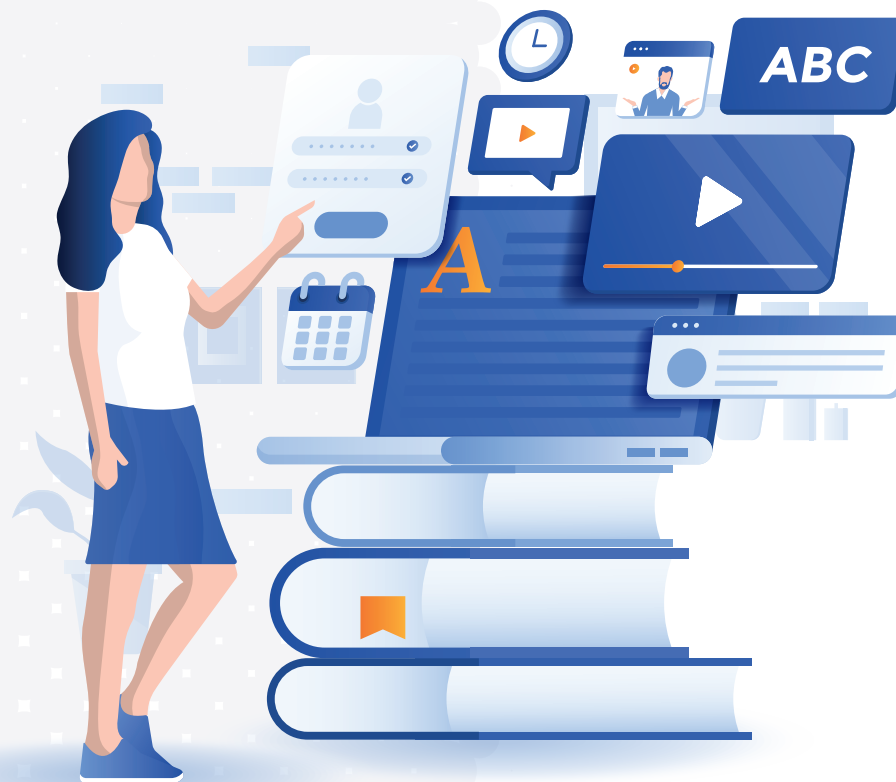

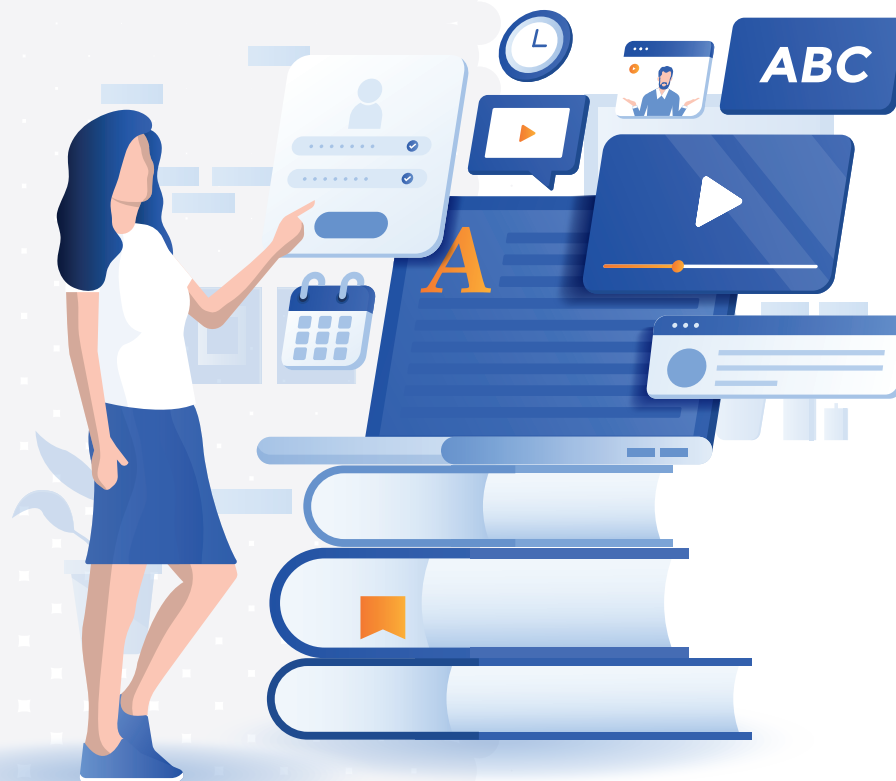

WORK PRACTICE PROGRAMME FEES

The Diploma is conferred on the successful completion of two years of study and two years of relevant work experience within an accounting or finance environment.

The Work Practice Programme is assessed via two Work Practice modules which can be completed either during study or after.

The Work Practice modules are available to purchase in your student TouchPoint portal when you are ready to commence them.

Each Work-Practice module is comprised of 4 tasks (8 in total) which align with the 8 core curriculum modules studied as part of the Certificate (Year 1) and Diploma (Year 2) syllabi.

WHAT IS IT?

- Two-year employment focussed training and education programme
- Fully funded by the Northern Ireland Department for the Economy and the European Social Fund
- Open to career-changers, school-leavers, recent graduates and mature learners in Northern Ireland, exploring a career in accounting through applied learning
- Open to current employees with a Northern Ireland based company, moving to a new job role and who wish to upskill

FORMAT

- Study with a local partner college one day a week during academic term
- Work with a Northern Irish employer the other four days
- Tuition is fully funded and apprentices are paid at least the National Minimum Wage
- Benefit from formal workplace and academic mentoring
- Graduate with two-years' work experience gained in a real business environment
- The programme is divided into four modules per year, with an additional work practice module also to be completed each year

- You should have a keen interest in accountancy/ finance

- Secure employment with an approved employer who will support you through the HLA programme
- Existing employees who are taking on a new role within the business and who wish to upskill may also be eligible
- Mature students (aged 21 years old and over) who do not hold the required minimum educational requirements may still apply based on qualifications and experience
